## *The 2018 Rigged Election in Iraq*

On May 12, 2018, in Iraq, there was the legislative election of 329 deputies for 4 years. The number of voters was 24.5 million and that of the candidates was 7000.

The election went through the voting machines, programmed to pull out the mercenaries of American, European and those of the oil companies, whatever the polls.

The organizers composed of the President of the Republic of Iraq (from Kurdish party of TALEBANI), the Prime Minister (Heider al ABADI) and a commission led by (Maan al HITAMI).

Under the orders of the Americans, the majority of the deputies of the northern half of Iraq should be the Kurdish deputies of Barezani and Talebani, especially in Kirkuk.

And to the south, the deputies must be Anti-Regime of Ayatollah of IRAN

At 7:00 pm on May 12, 2018, after the closing of the vote places, the CDs of 8443 voting machines sent to Baghdad and the director of the commission declared the results (faked) provisional.

From this moment, the demonstration of Turkmen and Arabs in Kirkuk and other cities begins.

They gather in front of the storage centers of the polls to prevent the displacement of the boxes towards Baghdad and the destruction of the evidences of the fraud. The event lasts 28 days 24 hours a day in Ramadan.

They demand the cancellation of the results by the machines and the manual counting.

The trick played out in 3 types:

- 1- In the south of Iraq, fill the vote boxes,
- 2- In the northern part of the Kurdish majority, change the CDs of the machines and force the voters in the hospitals and prisons and especially the civil servants.
- 3- In Kirkuk and cities with Majority Turkmen and Arab, change the CDs of the machines with prepared CDs.

To prepare the faked CDs of Kirkuk and other cities of the north before election, instead of sending them directly to these cities, the machines sent to Suleymaniye (Kurds of Talebani) supposedly to control, but in reality to prepare the rigged CDs with the identity of the machines, and after to Kirkuk and other cities.

In Kirkuk, there were 2196 voting machines, whose 1143 CDs of them are false.

The scammers who did not think of such a demonstration, first of all, ordered some soldiers who shoot in the air to scare and disperse the protesters, but without result.

The 6 Kurdish parties (the Change Party, the Kurdistan Islamic People's Party, the Islamic Party of Unified Kurdistan, the Democracy and Justice Party, the Communist Party of Kurdistan and the Kurdistan Islamic Movement) demonstrated against fraud in their cities also, and they declared that, they do not participate in a coalition with the parties of Barezani and Talebani.

Ayyaz ABBADI, party (AL-NASR) has made a complaint against the electoral commission.

One of the election commission officials said, all members were not aware of the fraud.

On May 16, 2018, Hushyar ABDULLAH (Kurd of Change Party) announced that the prime minister has closed his eyes to the fraud in Suleymaniyeh and Arbil.

On May 20, 2018, Saïd KAKAI, a member of the commission, declared that 70% of the elections in KIRKUK were fraudulent for 6 previous years.

On May 21, 2018, Turkmen deputies explain the problems to American officials and European Union in Baghdad.

The May 22, 2018 the ambassador of the United States travels to Kurds in Suleymaniyeh, demands of the Kurdish opponents that, they must be quiet for the interest of the Americans and the oil companies.

On May 23, 2018 the Prime Minister declared that the commission did not participate in the fraud.

Yan KOVIC (United Nations Representative in Iraq) states that in the election of Iraq there were massive frauds.

On June 03, 2018 Hassan TURAN (from Turkmen-Eli party) declares that for 15 years (2003-2017) the Kurds ruled Kirkuk and they made crimes and now with a fraudulent election, they want to return to Kirkuk and steal the wealth of the country.

On June 06, 2018 the Parliament of Iraq with a majority of 173 deputies decide the manual counting of all votes in Iraq, even the votes of the funds canceled by the electoral commission, the dismissal of the members of the commission, and cancellation of results by the voting machines.

On June 09, 2018, Kurdish terrorists, under the order of the Americans, attacked the neighborhood (Mosalla) in Kirkuk with K4 rockets and bombs, injuring 19 Turkmen civilians.

On June 20, 2018, Hushyar ABDULLAH (Kurdish, Change Party) said that Kurdish officials, who did not vote for the Iraqi president's party, were punished.

On June 24, 2018, in a meeting of parliament, Hassan TURAN (Turkmen) declares that in Kirkuk, there are 2196 vote boxes, of which 1143 are fraudulent, that is to say more than 50%. This is why it is necessary to manually count 100% of the boxes

On July 01, 2018, the Kurdish terrorists, under the order of the Americans, explode a car bomb in front of the Kirkuk polling station, hoping to destroy the vote boxes. The result is one dead and 20 wounded; the majorities are the police, without damaging the boxes.

Manual counting in Kirkuk starts on July 03, 2018. Until the fifth day of the count (On July 07, 2018), the polls of 360 boxes were counted with the interesting result.

Kurdish deputies of the Iraqi president's party, who on the list of Imam Hussein's polling station CD in Kirkuk had 1351 votes, in the box they had only 400 votes. In other polling stations, the same result. So far the Iraq government has refused to publish the final result of the fraud.

These criminal fraudsters, who play with the lives of 40 million Iraqis, are friends of the media and a part of Western politics, especially French.

These Kurdish terrorist fraudsters who failed to come to power again as in previous 15 years and steal public money, even with the help of Americans, Europeans and oil companies, shelled the commercial and residential districts, power lines, and

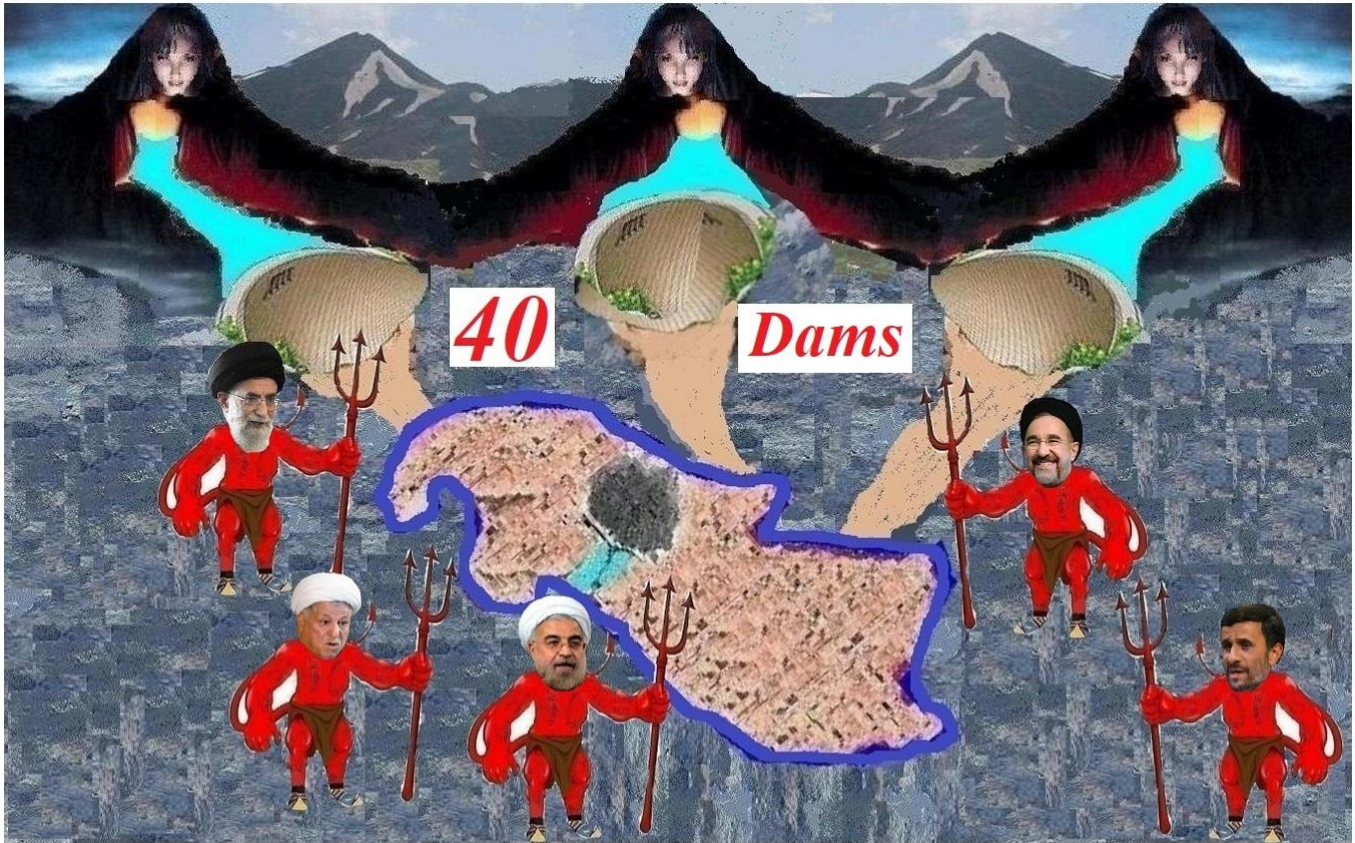
